In the year 1999 it was raised to Secondary School and in the year 2005 to a Senior Secondary school affiliated to CBSE, New Delhi. Affiliation No. 2130326

St. John's School is a Christian minority co-educational institution established and administered under the Article 30 of the Indian Constitution. The primary aim of this school is to impart to students sound education in keeping with the national aspiration and to make them morally, socially, physically, and mentally fit to become active and worthy citizens of India. We further aim at forming the youth of tomorrow in the values of hard work, honesty and universal brotherhood. MEDIUM OF INSTRUCTION

ADMISSION POLICY

Minimum age requirement for admission as on 1st April, 2026

Nursery	3 years
LKG	4 years
UKG	5 years

There will not be any entrance examination to Nursery and LKG. However, both the parents along with the child should be present at the meeting before admission.

The school authorities reserve all rights of admitting any child to the school. They are not bound to give reasons for the admission or rejection of any particular child.

Admission to higher classes, is based on vacancies available in each class and the admission is given on the basis of a student aptitude test. Priority is given to transfer cases from other districts. However, in respect of admission the decision of the Principal is final and binding.

No direct admission to class X and XII is permitted by CBSE. Therefore, we do not entertain any admission to classes X & XII.

Documents required at the time of admission:

1. Original birth certificate issued by the Municipal Corporation / competent authority.
2. Aadhar card of the child.
3. Photo of the child along with the parents.

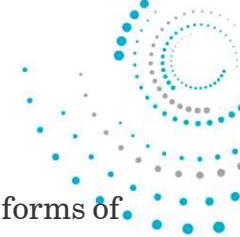
1. An attested photocopy of the original birth certificate, issued at the time of birth by the Municipal Corporation or the competent authority, must be attached with the Registration Form. No handwritten birth certificates will be accepted. It should be computerised certificate in the prescribed format by the relevant office. Hospital documents are not sufficient for this purpose.
2. Incomplete form will be rejected. Photocopy of the form will not be accepted. The Registration form is NOT TRANSFERABLE.
3. Date of birth once registered cannot altered. [(as per U.P.G.O. No. 1101/1(5)]

MEETING / IDENTIFICATION (for Nursery and LKG)

The meeting /identification date and time are intimated at the time of submitting the duly filled forms through an acknowledgment card. Change in date and time of meeting/identification will not be entertained.

The meeting is held for the identification of the candidates and parents more for security reasons than any other. During the meeting no academic tests are held, no questions are asked to measure the intelligence and knowledge of the child. Every child has a right to go to school and we make no discrimination on the basis of caste, creed, sex, economic status or social status. However, we admit only as many as we can. This is a co-educational institution keeping and equal number of seats for both boys and girls.

The candidates appearing for the meeting/identification should be accompanied by both the parents and not by any other relatives.



DRAW OF LOTS


After the meeting/identification of the candidates with their parents, the duly completed forms of the eligible candidates (over aged or under aged or repeaters etc. are treated as non-eligible) are put to draw by lots. This is done before the school community, by the students, during the morning school assembly. The picked out names of the candidates for admission shall be displayed on the School Notice Board on a scheduled date.

FEE STRUCTURE

1. Every pupil shall pay fees of 12 months.
2. Fees will be collected on quarterly basis.
3. No reduction of fee is made on account of summer and winter holidays or other vacations or temporary absence of students even if the classes are held online.

All payments must be made before the date specified in the fee book. If the last date is a holiday, payment must be made before that date. Parents must keep the receipts issued to them and produce them the proof of payment, if needed.

No child will be permitted to begin a new term unless all arrears due on his/her account have been cleared in full before the commencement of the new term.

Late Fees

A Late fee of Rs. 100/- per term will be charged for the delay of payment for more than a quarter. If not paid, It will remain as a due and the student's name will appear on the fee defaulter list. Paying the fee of the whole year together on a later date will not exempt anyone from late fee.

Admission to Class XI - is based on the performance in class X assessments percentage of attendance and the availability of seats. The cut off percentage of marks is as follows:

Science Stream : 75% (Internal), 80% (External)

Commerce Stream: 65% (Internal), 70% (External)

Stream wise subject combination is as follows :

Science Stream :

The students can choose five subjects - English, Physics and Chemistry are compulsory. (Biology/Maths, Informatics Practices /Hindi/Psychology/Physical Education are optional).

Those who opt for both Biology and Maths will have to study Maths privately.

Commerce Stream :


English, Business Studies, Accountancy, and Economics are compulsory. Optional Subject: Informatics Practices/Hindi/ Applied Maths/Psychology/Physical Education. As per the NEP, students can optional for additional subjects available.

CO-CURRICULAR ACTIVITIES

The school believes in all round education along with academics. It equally emphasizes on sports and games and cultural activities. These activities are conducted throughout the year and the winners are duly-awarded.

STUDENT - SPACE RATIO AND STUDENT-TEACHER RATIO

Our Institution has enough space for students and has adequate number of teachers for students which helps the teachers to focus on each and every student and to have 2-way interaction and make sure to eliminate all hindrances to an effective communication between them. We try to maintain an optimum class strength of 40 per class.

Whenever it is not possible for having offline classes we have an efficient system of taking online classes. Even when the offline classes take place, our teachers give online support to the students so that their learning is enhanced and they are able to complete the learning tasks well.

MAJOR EVENTS ORGANISED BY THE SCHOOL

The school organizes Annual Day, Annual Sports Day, and Multi-subject exhibition on a three year cycle basis. In addition to these, we celebrate all the national festivals and the major festivals of all the religions with special assemblies. We also conduct cultural and literary competitions, cultural titles competition, various sports and games competitions throughout the academic year. We encourage our students to participate in the competitions organized by CBSE and other leading agencies in the country.

EVENTS ORGANIZED FOR TEACHERS' TRAINING AND DEVELOPMENT

Every year the school conducts many capacity building programmes for the teachers in various topics. We also send the teachers for the seminars and workshops organized by the an Education Secretariat and the Centre for Excellence of CBSE.

EDUCATIONAL TOURS

Educational tours and picnics are arranged on payment as per the request from the parents and at the convenience of the school.

STUDENTS' VOICE

We have an active and engaged School Students' Parliament separately for seniors and juniors that has strong voice within the school community. We believe that all students have the potential to be leaders and it is our responsibility to nurture and develop those skills. Students are offered the opportunity to become student leaders through a democratic process.

Summer Classes

Enriching summer classes are conducted for the students to provide opportunity to develop their talents through music, dance, art and craft.

Computer Lab

The school has three Computer Labs, equipped with modern software and hardware and Internet. Free wi-fi is available in the school campus.



Laboratories

The school has well equipped laboratories for Physics, Chemistry, Biology and Mathematics, which provide a conducive environment for learning. We also have a composite lab for other common subject activities. ICT labs are available for students for better learning experience.

Dance and Music

We have four trained teachers in Dance and Music and have well furnished music and dance rooms to provide the students training in classical and contemporary dance and music.

Library

The school library accommodating carefully selected books on various subjects is a resource centre for the students. Books are issued to students in their assigned period.

Value-Education/Counselling

The school aims not only forming individuals who are intellectually competent but also morally sound. Along with academics, periods are allotted for value education also. There is also provision for counselling and guidance by experienced counsellors.

House System

To foster healthy competition, team spirit and leadership, students are grouped into four houses. Each house is headed by teacher wardens and student captains.
